**Indication of any immediate medical attention and special treatment needed**

Treat symptomatically.

<b>Appropriate engineering controls</b>	<p>Engineering controls are used to remove a hazard or place a barrier between the worker and the hazard. **Information on toxicological effects**

<b>Inhaled</b>	There is some evidence to suggest that the material can cause respiratory irritation in some persons. The body's response to such irritation can cause further lung damage. Not normally a hazard due to non-volatile nature of product Inhalation of oil droplets or aerosols may cause discomfort and may produce chemical inflammation of the lungs.
<b>Ingestion</b>	The material has <b>NOT</b> been classified by EC Directives or other classification systems as "harmful by ingestion". This is because of the lack of corroborating animal or human evidence.

<b>WHITE MINERAL OIL (PETROLEUM)</b>	<p>The materials included in the Lubricating Base Oils category are related from both process and physical-chemical perspectives; The potential toxicity of a specific distillate base oil is inversely related to the severity or extent of processing the oil has undergone, since:</p> <ul style="list-style-type: none"> <li>The adverse effects of these materials are associated with undesirable components, and</li> <li>The levels of the undesirable components are inversely related to the degree of processing;</li> <li>Distillate base oils receiving the same degree or extent of processing will have similar toxicities;</li> <li>The potential toxicity of residual base oils is independent of the degree of processing the oil receives.</li> <li>The reproductive and developmental toxicity of the distillate base oils is inversely related to the degree of processing.</li> </ul> <p>Unrefined &amp; mildly refined distillate base oils contain the highest levels of undesirable components, have the largest variation of hydrocarbon molecules and have shown the highest potential cancer-causing and mutation-causing activities. Highly and severely refined distillate base oils are produced from unrefined and mildly refined oils by removing or transforming undesirable components. In comparison to unrefined and mildly refined base oils, the highly and severely refined distillate base oils have a smaller range of hydrocarbon molecules and have demonstrated very low mammalian toxicity. Testing for sensitisation has been negative.</p> <p>The substance is classified by IARC as Group 3: <b>NOT</b> classifiable as to its carcinogenicity to humans. Evidence of carcinogenicity may be inadequate or limited in animal testing. Oral (rat) TCLo: 92000 mg/kg/92D-Cont. Generally the toxicity and irritation is of low order.
