White oils and highly/solvent refined oils have not shown the long term risk of skin cancer that follows persistent skin contamination with some other mineral oils, due in all probability to refining that produces low content of both polyaromatics (PAH) and benz-alpha-pyrenes (BaP)</p> <p>The substance is classified by IARC as Group 3: NOT classifiable as to its carcinogenicity to humans.
